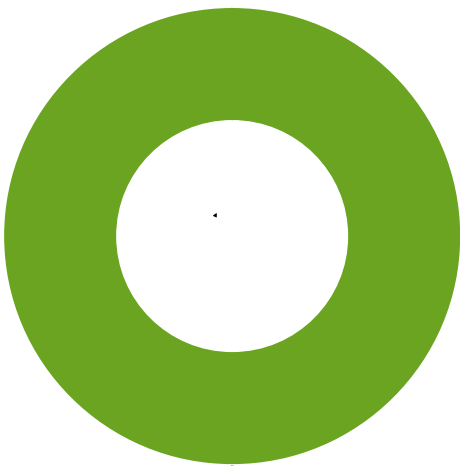
Onsite Support

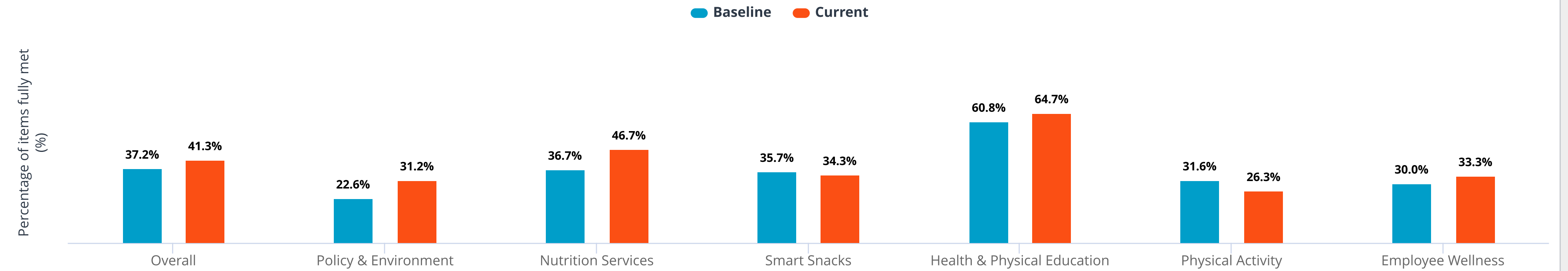
